General condition

AIMS acknowledges that privacy is an important issue, and our website's practices comply with all applicable Sri Lankan laws.

This privacy statement explains what information is collected and how it is used when you visit the AIMS central website. This Privacy Policy may be subject to periodic updates. You should periodically review this page to determine whether this policy has been modified.

At the time of writing, users are not required to register or provide any personal information to access the AIMS primary website. No personally identifiable information is stored or collected without the knowledge and consent of the user.

Wherever personal information is collected (e.g., via web forms for prospectus requests, study applications, feedback, etc.), the user will be aware of what information is being provided and why. What data is gathered?

• Log records

Similar to the majority of websites, this site automatically records certain information regarding each request. Other than logging your IP address and session information, the AIMS website does not routinely collect or store any personal information about site visitors. Session information consists of the time and duration of your visit, the files you requested, and the browser you used.

This information will only be accessible to the AIMS personnel or their agents authorizing. The information will be retained by AIMS and used solely for managing the site system, identifying faulty links, monitoring bugs, compiling statistics, and conducting audits.

Relevant subsets of this data may be shared with computer security teams as part of their investigations into computer misuse involving this website or other computing equipment. Data may be transmitted to the administrators of other computer systems in order to investigate access issues or system misconfigurations. Data may be included inadvertently in information provided to contractors and computer maintenance companies working for AIMS, in which case it will be protected by appropriate non-disclosure agreements.

• Personal information on forms

This website provides a selection of fillable forms. AIMS holds this information in accordance with the provisions of the Data Protection Act of 2018, which is described on the pages containing these forms. The information collected will only be used for the stated purpose, and by providing it, you consent to AIMS storing it for that purpose. See also our document on data protection policy.

A. Cookies

AIMS may send a "cookie" to your computer's hard drive when you visit the Website. Cookies are text files that identify a user's computer to our server; however, they do not provide AIMS with access to your computer or any information about you other than the data you choose to share.
